5. Encumbrance certificate in original from the competent Government authority.

- 6. Original FDRs of Endowment fund of Rs. 5 lakhs and Reserve fund Rs. 7 lakhs in joint account of a scheduled bank for a period of 5 years.
- 7. Affidavit on Rs. 100/- stamp paper in the prescribed format with notary attestation.(format enclosed)
- 8. Approved faculty list.(format enclosed)

On receipt of above documents, further action will be taken in the matter.
